Effective August 1, 2017

Pursuant to R.S. 13:844 & R.S. 9:5217

Act 173 of the 2017 Regular Legislative Session

NOTE: Any document filed for recordation must be captioned as to type of act on first page, have a 2" margin on the top of 1st page with 1" margin on additional pages, have a 1" margin on the bottom and sides, and must not have type size smaller than 8 point.

FEES FOR ALL DOCUMENTS (with the exception of those listed below):

Fees are per index type* and include up to 10 names and 1 certified copy and \$5.00 LCRAA fee (R.S. 13:754)
